Sir,

With reference to the subject cited above, I have the honour to submit herewith the required information as sought for vide your letter under reference in connection with the proposed video conference to be held on 22nd May /2012 in respect of Food, Civil Supplies & Consumer Affairs Department , Kajalgaon Sadar Sub-Division of Chirang District .

1. Procurement of Paddy during 2012-13 Season :- Kajalgaon Sadar Sub-division has not been declared as a paddy procurement Centre. Moreover the Sub-division is not a paddy surplus area.
2. Uploading of all periodical allotment orders have been continuing in district website through N.I.C.

Computerization of PDS is in progress . Effort have been made to catalogue the database leading to its computerization & digitisation.

A high level meeting under the Chairmanship of Principal Secretary , B.T.C. was held on 15.05.2012 wherein necessary guidelines have been given for verification of existing F.I.Cards .Contingency plans have been chalked out to complete the verification within the given period of time i.e. 16/08/2012.

Up-to-date figures on detection of bogus F.I.C. of Kajalgaon Sadar Sub-division is as follows:-

1. A.P.L. = 30
2. B.P.L. = 104
3. A.A.Y. = 15
4. M.M.A.S.Y. = 1

Total = 150 nos.

B.P.L ,A.A.Y. and M.M.A.S.Y. have been substituted by issued of fresh cards as per recommendation of concerned B.D.O.'s.

3. 17 (Seventeen) F.P.Shop dealers have been notified under Ammar Dokan Scheme . But in absence of any prominent wholesalers the scheme has not taken its force.
4. Streamlining of price line & supply position of L.P.G. cylinder etc:-

Regular meeting on monthly basis have been held with the GPSS / F.P.Shop dealers to monitor the price line & to maintain a hassle free public distribution system .There is no prominent wholeseller of open market trade articles in the Sub-division.

Supply of L.P.G. Cylinders to registered consumers have remain erratic during last month & the position has not improved substantially till date .

Supply position of domestic L.P.G. Cylinders to the distributors of this sub-division is as follows :-
